Description: Offers free, temporary childcare during family emergencies, including but not limited to: medical emergencies, unexpected illness, accidents, unemployment, mental health episodes, unexpected death, domestic violence, homelessness, legal issues, or unstable/unsafe housing. Available 24/7.

Description: Offers child care subsidy. **Eligibility:** Working families who earn less than 200% of the federal poverty line for their household size.

Also, Eligibility consideration can be approved for: 1. teen parents ACTIVELY attending high school 85% of the time with no work requirement; or 2. parents or guardians ACTIVELY attending college with at least a 2.0 grade point average (limited to a 2 year degree or up to 24 months of a training course). The parent/guardian student must work an average of 17.5 hours per week.

Description: Offers family and career navigation services: job training, job placement, career advancement and benefits management. It also helps individuals search for quality child care services while in training, navigate available child care subsidy sources, and access SWFI child care subsidy if ineligible for any of the funding sources. **Eligibility:** The individual must be 18 years and older, who are the primary caregivers of one or more children under the age of 13 (or children 14 years and older with a disability) and who wish to increase skills through short-term training related and career advancement in the following industries: health care, advanced manufacturing and information technology. Must be willing to develop a career plan and be motivated to activity work on goals. See back page for more info.

Description: Offers child care subsidy. Put in place to increase enrollment in training programs and reduce program drop-out rates. **Eligibility:** The individual must be in a training program and also: 1. must be a Monroe County resident; 2. have a child under age 13 or have a disabled child 18 years old or younger; and 3. have an income under 275% of federal poverty line. The individual cannot receive TANF child care subsidies. Child care coverage will continue for 3 months after the individual completes his/her training program while he/she completes job search.

Description: Offers child care subsidy. **Eligibility:** Public Housing Residents ONLY, ineligible for IEDC and URI. RHA will pay for child-care until the individual is approved for other funding sources. If the individual is in a training program, coverage will be extended 30 days after program completion. The family will work with a case manager on employment budgeting and credit.
