# **Child Care Resources Supplemental Information**

# Federal Child Care and Development Block Grant (CCDBG)-NYS- County DHS Child Care Subsidy-Income Eligible Childcare:

Subsidies for child care services /Child care subsidy paid directly to providers caring for eligible families

- Monroe County residents with children under age 13 (Definition of eligible child makes
  exception for child who turns 13 during school yr. so child will continue to receive services
  through the end of school yr.)
- Individuals work an average of 25 hours/week
- Income is below 200% of the federal poverty level Monroe County residents with children under age 13; work an average of 25 hours/week; income under 200% of federal poverty level

#### Federal CCDBG – NYS- County DHS Child Care Subsidy Program-TANF Assistance:

Subsidies for child care services /Child care assistance paid directly to providers delivering care to children of eligible individuals receiving TANF/public assistance participating in workforce activities (e.g., working or searching for work)

- Individuals receiving TANF/public assistance
- Participation in workforce activities (e.g., working or searching for work Parents meeting work or training requirements of TANF/ public assistance

### Workforce Development Institute Child Care Subsidy Facilitated Enrollment Program (WDI CCSFEP):

Subsidies for child care services /Child care subsidy for eligible families

- Working parents
- Income is below 275% of the federal poverty level Monroe County residents with children under age 13; work an average of 25 hours/week; income below 275% FPL

## **NYS Upstate Revitalization Initiative:**

Child care subsidy for eligible families /Non-COVID Child Care Funds - Subsidy

- Parents participating in a limited type of training program
- Income is below 275% of the federal poverty level Parents engaged is specific types of training that are not eligible for any other child care subsidy program

#### **Special Needs Referral Program:**

Child Care Resource and Referral Agenda provides enhanced referral services and equipment loan for children with special needs while in care.

- CCRR program operations
- Purchase of equipment to be loaned to child care providers (\*or families during COVID-19)
- Parents in need of assistance with special needs childcare
- Providers needing equipment loans -Parents in need of assistance with special needs childcare referrals Providers needing equipment loans (\* or families during COVID-19)

#### New York State Child Care Development Block Grant (NYS CCDBG)- Enhanced Childcare Subsidy:

Increased subsidy to providers serving children with special needs -Qualifying diagnoses include: visual impairment; deafness or other hearing impairment; orthopedic impairment; emotional disturbance; intellectual disability). Enhanced reimbursement to providers serving eligible enrolled children Recipients of Monroe County childcare subsidy with children:

- Under 18 years of age and a child with special needs or
- Under 19 years of age, full-time student in secondary school or in an equivalent level of vocational/ Technical training, and a child with special needs Recipients of Monroe County childcare subsidy with children: -Under 18 years of age and a child with special needs or -Under 19 years of age, full-time student in secondary school or in an equivalent level of vocational
